Use of Multi-Criteria Decision Analysis to Inform Decisions on the Allocation of Resources aimed at Strengthening Sanitary and Phytosanitary (SPS) Capacity

Programme

Overview

The Standards and Trade Development Facility (STDF) is supporting the development of a decision-support tool, based on Multi Criteria Decision Analysis (MCDA), to help countries prioritize options for the enhancement of sanitary and phytosanitary (SPS) capacity. The purpose of this tool is to improve the effectiveness of decisions on where to allocate public, private and/or donor resources aimed at strengthening SPS capacity. As such, the tools helps to: (i) enhance the economic efficiency of SPS resource allocation decisions, such that scarce resources are allocated in a manner that best meets a country's economic development, poverty alleviation, public health and/or other objectives; (ii) promote more transparent and accountable choices between multiple investment options; and (iii) facilitate more inclusive decision-making processes involving diverse stakeholders.

The MCDA framework was used in Mozambique in April 2011 to identify and prioritize options to strengthen SPS capacity, and in Zambia in July 2011. These initial applications have been beneficial to assist decision-makers in both countries to identify priorities that might guide the allocation of resources by government agencies, the private sector and/or donors. They have also been invaluable to refine and improve the methodology and process through which it is used. Based on these applications, and possible additional applications in the future, we intend to finalize and publish the MCDA Guide as a decision-support tool for SPS experts in developing countries.

Regional Workshop on the Use of MCDA to Inform SPS Decision-making in Africa

The purpose of the regional workshop will be to: (i) present the MCDA approach; (ii) share practical experiences from Mozambique and Zambia where the approach has been used in consultation with national stakeholders; and (iii) equip SPS experts from selected other countries and Regional Economic Communities in Africa with knowledge and skills to apply this approach.

Participants are expected to comprise mid- to high-level officials with direct responsibility for food safety, animal health, plant health and/or trade. Participants will be encouraged to disseminate and make use of the MCDA approach in their own work, in consultation with relevant stakeholders, after the event.
